# UUCM Board of Trustees Minutes June 8, 2022

### The minutes of the May 25, 2022 meeting were approved by consensus.

## Treasurer's report:

- With the \$1900+ in reserves in the Operations account, we have enough cash to pay the bills through June 30.
- FY '22 pledges are 92% paid. Trish will send a reminder to at least one pledger to finish paying the pledge.
- We have funds from early payment of some of the Matching Challenge pledges. This money will provide a cushion for the beginning of FY '23.
- The report was accepted as presented.

## Molly Nolan's offer for summer RE:

- It's too late to implement any kind of RE program for summer; planning should have started in March.
- Rev. Tony will contact three families re: what kind of program/offerings they'd like for their children if we were able to start a program for fall. Good date to start: Sunday August 21, 2022.
- Rev. Tony will forward to Molly the Soul Matters programs as he receives them. Soul Matters is in our budget.
- Molly and Rev. Tony will talk via Zoom on Wed. June 15.
- At least four volunteers will be needed to carry an RE program, and at least five children.
- An RE program fits with our goal of increasing opportunities for spiritual growth, outreach, and marketing.

### Worship Associates:

- Need someone to serve as chairperson of the team.
